GUIDELINES FOR PUBLIC COMMENT AT RIVANNA BOARD OF DIRECTORS MEETINGS

If you wish to address the Rivanna Board of Directors during the time allocated for public comment, please raise your hand or stand when the Chairman asks for public comments.

Members of the public requesting to speak will be recognized during the specific time designated on the meeting agenda for "Items From The Public, Matters Not Listed for Public Hearing on the Agenda." Each person will be allowed to speak for up to three minutes. When two or more individuals are present from the same group, it is recommended that the group designate a spokesperson to present its comments to the Board and the designated speaker can ask other members of the group to be recognized by raising their hand or standing. Each spokesperson for a group will be allowed to speak for up to five minutes.

During public hearings, the Board will attempt to hear all members of the public who wish to speak on a subject, but it must be recognized that on rare occasion comments may have to be limited because of time constraints. If a previous speaker has articulated your position, it is recommended that you not fully repeat the comments and instead advise the Board of your agreement. The time allocated for speakers at public hearings are the same as for regular Board meetings, although the Board can allow exceptions at its discretion.

Speakers should keep in mind that Board of Directors meetings are formal proceedings and all comments are recorded on tape. For that reason, speakers are requested to speak from the podium and wait to be recognized by the Chairman. In order to give all speakers proper respect and courtesy, the Board requests that speakers follow the following guidelines:

- Wait at your seat until recognized by the Chairman.
- Come forward and state your full name and address and your organizational affiliation if speaking for a group;
- Address your comments to the Board as a whole;
- State your position clearly and succinctly and give facts and data to support your position;
- Summarize your key points and provide the Board with a written statement, or supporting rationale, when possible;
- If you represent a group, you may ask others at the meeting to be recognized by raising their hand or standing;
- Be respectful and civil in all interactions at Board meetings;
- The Board may ask speakers questions or seek clarification, but recognize that Board meetings are not a forum for public debate; Board Members will not recognize comments made from the audience and ask that members of the audience not interrupt the comments of speakers and remain silent while others are speaking so that other members in the audience can hear the speaker;
- The Board will have the opportunity to address public comments after the public comment session has been closed;
- At the request of the Chairman, the Executive Director may address public comments after the session has been closed as well; and
- As appropriate, staff will research questions by the public and respond through a report back to the Board at the next regular meeting of the full Board. It is suggested that citizens who have questions for the Board or staff submit those questions in advance of the meeting to permit the opportunity for some research before the meeting.



Map released: Thurs. June 20, 2024



SUBJECT: REQUEST FOR AUTHORIZATION TO DECLARE A DROUGHT WATCH, WARNING OR EMERGENCY

DATE: JUNE 25, 2024

Based on a recent determination by the Commonwealth of Virginia's Drought Monitoring Task Force (VDMTF) that a drought "Watch" exists for the entire state, this recommendation is to authorize the Executive Director to officially declare a Drought Watch, and after consultation with the Chair of the Board of Directors, a Drought Warning or Drought Emergency should conditions later reach the levels defined by the guidance in the regional "Drought Response and Contingency Plan". The Executive Director is authorized to provide appropriate immediate notification to the City, Albemarle County Service Authority, Albemarle County and the news media at any time a new drought stage has been declared.

Our regional "Drought Response and Contingency Plan" (DRCP) established criteria for the drought stages and the responsibility for the RWSA Executive Director to make recommendations to the Board of Directors for the official declaration of those drought stages (Watch, Warning, Emergency) as water supply conditions evolve. Recent elevated temperatures, minimal precipitation with no near-term forecast of precipitation, and the assignment of a "Watch" for our area by the VDMTF on June 24, 2024, serve as the basis for this recommendation to proactively initiate our water supply and drought management program.

Additional information includes:

- Our three reservoirs serving the Urban area are near maximum capacity and are 98% full with a total water storage of 2.6 billion gallons. However, two of those reservoirs, Ragged Mountain and Sugar Hollow, are no longer spilling over their dams. We anticipate the third reservoir and the one of most concern, South Rivanna, may stop spilling soon due to low and declining flows in the Moormans River.
- We will request our water resources management consulting firm (Hazen Engineers) to provide a probability-based analysis of drought potential to provide objective guidance, as recommended by the DRCP.
- We will coordinate meetings of the Rivanna Regional Drought Response Committee established by the DRCP including staff from the Albemarle County Service Authority,



City of Charlottesville Utilities Department, Albemarle County and RWSA to monitor ongoing drought conditions.

- On June 24, 2024, water production for the Urban system totaled 12.66 million gallons, an indication of daily water demand during hot weather in our urban community.

We will implement operational measures to minimize water usage from the South Rivanna Reservoir (SRR) and increase water usage from the Ragged Mountain Reservoir if the water level in the SRR decreases to a level of one foot below the top of the dam.

Board Action Requested

Authorize the Executive Director to officially declare a Drought Watch, and after consultation with the Chair of the Board of Directors, a Drought Warning or Drought Emergency should conditions later reach the levels defined by the guidance in the regional "Drought Response and Contingency Plan". The Executive Director is authorized to provide appropriate immediate notification to the City, ACSA, Albemarle County and the news media at any time a new drought stage has been declared.
