Minutes of Special Meeting
August 15, 2016

A special joint meeting of the Rivanna Water & Sewer Authority (RWSA) Board of Directors and the Rivanna Solid Waste Authority (RSWA) Board of Directors was held on Monday, August 15, 2016 at 2:00 p.m. in the 2nd floor conference room, Administration Building, 695 Moores Creek Lane, Charlottesville, Virginia.

Board Members Present: Mr. Tom Foley, Mr. Mike Gaffney – presiding, Ms. Kathy Galvin, Mr. Maurice Jones, Mr. Gary O’Connell, Ms. Judith Mueller and Dr. Liz Palmer.

Board Members Absent: None.

Staff Present: Ms. Teri Kent.

Also Present: Ms. Rachel Meyer, Titan Consulting Group.

1.0 Call to Order

The regular meeting of the RWSA Board of Directors was called to order by Mr. Gaffney on Monday, August 15, 2016 at 2:04 p.m., and he noted that a quorum was present.

Mr. Gaffney read the following statement: The Rivanna Solid Waste Authority Board and the Rivanna Water and Sewer Authority Board are holding special meetings today called by the Chair. Neither board will be conducting any public business today other than going into a joint closed session to consider personnel matters. No action is expected to be taken at the end of the joint closed session by either board other than to adjourn.

Ms. Mueller moved, seconded by O’Connell, to adopt the following resolution:

RESOLVED that the Board of Directors of the Rivanna Water and Sewer Authority Board enter into a closed meeting with the Rivanna Solid Waste Authority to discuss confidential

49 **The Rivanna Water and Sewer Authority Board of Directors meeting was resumed in open**
50 **session at 3:59 p.m.**

52 **Mr. Foley entered the following resolution, seconded by Mr. O’Connell:**

54 **WHEREAS, the Rivanna Water and Sewer Authority has convened a closed meeting on this**
55 **date pursuant to an affirmative recorded vote and in accordance with the provisions of the**
56 **Virginia Freedom of Information Act; and**

58 **WHEREAS, Section 2.2-3712.D of the Code of Virginia requires a certification by the**
59 **Rivanna Water and Sewer Authority that such closed meeting was conducted in conformity**
60 **with Virginia law;**

62 **NOW, THEREFORE, BE IT RESOLVED that the Rivanna Water and Sewer Authority**
63 **hereby certifies that, to the best of each member’s knowledge, (i) only public business matters**
64 **lawfully exempted from open meeting requirements by Virginia law were discussed in the**
65 **executive meeting to which this certification resolution applies, and (ii) only such public**
66 **business matters as were identified in the motion by which the closed meeting was convened**
67 **were heard, discussed or considered in the closed meeting by the Rivanna Water and Sewer**
68 **Authority.**

70 **Mr. Gaffney called for a roll call vote: Ms. Mueller – absent; Mr. Jones – aye; Ms. Galvin –**
71 **absent; Mr. Gaffney – aye; Dr. Palmer – aye; Mr. Foley – aye; and Mr. O’Connell – aye. The**
72 **motion passed by a 6-0 vote. Ms. Galvin was absent from the vote.**
